- Application Assistance**-i.e. HEAP, Medicare Extra help, Medicare Savings Programs
- Healthy U**”- teaches life skills as well as how to manage one’s chronic disease;

Eligibility Requirements- vary from program to program; determined by an assessment performed by BH-AAA8

Costs for Receiving Services- The long-term care consultation is a free service. Some programs have a co-pay requirement while others have no cost associated with receiving the service. Donations are accepted for all programs.
